The Bucket Banked is a banked slalom snowboard race and fundraiser held in the memory and spirit of Grand County native and Winter Park Competition Center alum, Ben Lynch. Join us April 3 for the inaugural banked slalom snowboard event and silent auction. Proceeds to benefit the Grand Foundation's H.O.P.E Fund (Healing Opportunities through Prevention Efforts). The H.O.P.E. Fund is dedicated to supporting and expanding Grand County mental health advocacy and services, substance abuse prevention and recovery services, and access to outdoor recreation as a protective factor to support mental and physical well-being.

The entry fee is \$35 and the event will be capped at 250 racers (snowboard only). Prizes will be awarded to 1st, 2nd, and 3rd place finishers in each category. Open Classes podium winners will have donations to the Grand Foundation made in their names as follows:

TENTS AND FLAMMABLES REQUIREMENTS

FOR VENDERS/DEMOS AT WINTER PARK RESORT AND THE VILLAGE AT WINTER PARK (rev. 4-11-2018)

TENTS

Please be aware of the variable weather extremes which may be present in an alpine environment. Unexpected weather and wind gusts in excess of 50 miles per hour can occur suddenly and without warning. All tents are to be adequately roped, braced and anchored to withstand the elements of weather and prevent against collapsing at all times both during the day and overnight. Tents must be able to withstand winds in excess of 50 miles per hour. All tent corners should be secured. If a tent is permitted to be left standing overnight, it is suggested to lower the tent to the lowest position possible. Umbrellas are to be secured and anchored to the same standards as tents. Stakes are not to be used at Winter Park Resort or in the Village at Winter Park unless locates have been done and permission granted. Be prepared to bring weights, tie-downs and/or other accessories as these items are not supplied by the Resort or the Village. You are responsible for any injury or damage due to “flying” tents or umbrellas or stakes put into underground utilities. Securing/Anchoring suggestions include:

- Weights (minimum 40 lbs. for each corner)
 - Sandbags – no sand or other filler provided
 - Water containers - at least 5 gallons each
 - Concrete weights (cinder blocks not recommend as they are too light)
- Tie-downs (i.e. to secure corners to weights, or to secure corners directly to a vehicle or trailer)
 - Adjustable straps are recommended, or if using rope, it must be able to be tied securely

NO Smoking is allowed inside, or within 20 feet of a tent.

FLAMMABLES

NO Open Flames or any other devices emitting flame, fire or heat are allowed to be inside or under the tent.

Outdoor cooking may be allowed OUTSIDE of the tent at resort approved locations, at least 10 feet away from exits, combustibles or buildings/structures.

- Portable LP-gas containers that are **in use** are to be located outside of the tent with the safety release valve pointed away from the tent. The containers must be securely fastened to prevent accidental movement, tampering or other damage.
- Portable fire extinguisher(s) must be available, and placed no more than 30 feet away from the cooking/flammables location(s). Portable fire extinguishers are not supplied by the Resort or the Village.

Generators and other internal combustion power sources shall be at least 20 feet from any tent, and shall be isolated from contact with public by means of fencing, enclosure or other approved means.

REFUELING AND FUEL STORAGE

No filling or refilling of propane or butane cylinders during events. No refilling of non-refillable cylinders permitted at any time.

No refueling of flammable liquid fuel equipment, unless approved by the Resort or Village event manager, and shall only be performed at approved locations, at least 20 feet away from any tent.

Flammable and combustible liquids and portable LP-gas containers **not in use** shall be stored in an approved manner at approved locations, at least 50 feet from any tent.

SPECIAL PERMITS

Tents covering an area in excess of 400 sq. ft. require a Special Permit from the East Grand Fire Protection District. An inspection may be necessary. You are responsible for contacting, scheduling the application and inspection, completing the permitting process and any applicable fees.
